PRESIDENTS REPORT

I am pleased to present my first President's Report.

After last year's AGM I was a little daunted at hearing the accomplishments of Geoff Wallis our immediate past president and life member. My initial thoughts were defrayed now realising the strength of our dedicated committee and the number of volunteers who in effect make this club successful. May I add that there have been numerous members who have been very generous with their wise counsel. There were those who in my first weeks who sought me out to offer assistance for which I am grateful. All in all I believe we are moving in the right direction as a club continuing the solid base of previous years.

In the early part of this year we changed from "key entry" access to "swipe card entry". This was part of the Maroondah council continuous improvement plan. Our changeover was brought forward after a break in at Mr Fox which prompted council to act a little faster than we were expecting. This change caused some concerns regarding who should have access cards and there were those who seemed anxious when they were not in the first distribution. May I say that the allocation was done in a manner to maintain competition continuity and security during the rollout. Clubhouse access will be monitored periodically via security reports. The auto alarm is set for midnight and any changes would need at least two weeks' notice. A card register has been set up and will be annually monitored.

Our weekly competitions are very well supported and there is a very healthy competitive spirit both on and off the course. Your match committee are to be congratulated for the manner in which they go about their tasks ensuring the smooth running of our competitions.

Our pennant season was a mixture of highs and lows and those who represented our club are to be congratulated. The ladies fell just short of the mark due to a rule which quite obviously needs to be changed. The success of our senior men's "Gold and "Blue" teams is being spoken about in "legend" terms and those who took part are elevated to their own "hall of fame". A big vote of thanks to Len Flaherty our senior pennant co-ordinator and of course everyone who participated.

TREASURERS REPORT

I am pleased to submit my third Treasurers Report, Profit and Loss comparison, Balance sheet and accompanying auditor's report for the year ended 30 June 2017. All figures below exclude GST.

The club had income for the year of \$207,891, which was down compared to the 2015/16 (\$227,555).

This was mainly due to reduced bar sales, down \$12,301.

Cost of sales for the year of \$55,438 was also down on 2016/17 (\$67,619).

This was mainly due to reduced bar purchases, down \$12,844.

Expenses for the year \$164,903 were lower than 2015/16 (\$172,392).

Expenses for the year included:

- \$23,040 for GolfVic/VGL dues. This is an ongoing cost:
- \$8,920 for Insurance. This is an ongoing cost;
- \$7,676 for the bar refurbishment. This is a one off cost;
- \$5,058 for annual Mi-Club access and support. This is an ongoing cost;
- \$5,345 depreciation expense for furniture. This is a one off cost.

As a result, the club had an operating loss of \$12,448 compared to an operating loss in 2015/16 of \$12,396.

The club's financial position is still solid with \$73,804 in current assets. I have recommended to the committee for an increase in membership fees from \$120 to \$140 for ordinary members and an increase in annual competition fees from \$140 to \$150. This will allow us to operate at or near even for the coming year.



We have completed our second year of recording using the streamlined Chart of Accounts and the Profit and Loss statement includes direct comparisons on previous year income and expenditure by account.

In closing I would like to thank Des Pinfold and Ross Harrison for their assistance with membership collection and completing the banking when I was not available.

INDEPENDENT AUDIT REPORT

TO THE MEMBERS OF RINGWOOD GOLF CLUB INC.

<u>Scope</u>

We have audited the attached special purpose financial report comprising the Profit and Loss Statement and Balance Sheet of Ringwood Golf Club Inc. for the year ended 30th June 2017. Our audit has been conducted in accordance with Australian Auditing Standards. Our procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial report. These procedures have been undertaken to form an opinion whether, in all material respects, the financial report is presented fairly in accordance with the accounting policies. (These policies do not require the application of all Accounting Standards and UIG Consensus Views).

The audit opinion expressed in this report has been formed on the above basis.

Qualification

As is common for organisations of this type, it is not practicable for Ringwood Golf Club Inc. to maintain an effective system of internal control over membership fees and fundraising income until their initial entry in the accounting records. Accordingly, our audit was limited to amounts recorded.

We did not observe the counting of the physical inventory stated at \$ 9,910.64 as at 30^{th} June 2017.

Qualified Audit Opinion

In our opinion, except for the effect of such adjustments, if any, as might have been determined to be necessary had the limitation discussed in the qualification paragraph not existed, the financial report presents fairly in accordance with applicable Accounting Standards and other mandatory professional reporting requirements, the financial position of Ringwood Golf Club Inc. for the year ended 30th June 2017.
